## ***In 2023, we...***

- knew it was time to bring on a ***expert Facilities Manager to help us maintain and update the RMH.*** This has yielded significant upgrades both inside and outside our Home.
- ***added five new breast pumps for nursing mothers, a new outdoor shed to help protect tools*** and other lawn care items, ***replacement of all East Tower doors*** and continued land development efforts that support sustainable and preventative maintenance initiatives.

- our amazing volunteers provided just shy of ***11,000 hours of service across all our program offerings*** throughout the year.
